Narita Bahra QC

Narita Bahra QC is one of the most sought after and able leading defence barristers.

The Hon. Mrs Justice Cockerill DBE

Mrs Justice Cockerill was called to the Bar in 1990 (Lincoln's Inn) and appointed Queen's Counsel in 2011. Prior to her appointment she sat as an arbitrator in a variety of arbitral proceedings and since 2016 as a Deputy High Court Judge in the Commercial Court and Administrative Court.



Sir David Foskett

Sir David Foskett was appointed to the High Court in 2007. He had a distinguished career at the Bar with a broad civil law practice. Following his retirement as a High Court Judge, he has joined the set as a door tenant and accepts appointments as an arbitrator, mediator or early neutral evaluator at 39 Essex Chambers.



Lord Justice Gross

Lord Justice Gross was appointed to the Court of Appeal in 2010. He was Senior Presiding Judge for England and Wales from 2013 to 2015 and has been Lead Judge for International Relations from early 2018.



Matthew Harman

Matthew Harman has over 30 years' experience as a Costs Lawyer and Costs Draftsman and was a founding partner of Harmans. He was among the first to qualify as a Costs Lawyer, and is a former Chairman and Hon. President of the Association of Costs Lawyers.



Isabel Litherland

Isabel Litherland is a solicitor qualified in both England and Scotland. After years as a civil litigation partner who routinely relied on the evidence of experts she joined Bond Solon in 2005 and was Head of Expert Witness Group for several years.



Dr Jock Mackenzie

Dr Jock Mackenzie trained at Barts in London and worked as a hospital physician before retraining as a solicitor specialising in claimant clinical negligence. Jock is both an AvMA and Law Society Clinical Negligence panel member and is also a Solicitor-Advocate with Higher Rights of Audience.

Lord Woolf

Lord Woolf was appointed to the Queen's Bench Division of the High Court of Justice in 1979, as Lord Justice of Appeal in 1986 and a Lord of Appeal in Ordinary in 1992. Between 1996 and 2000 Lord Woolf held the position of Master of the Rolls and in 2000 was appointed Lord Chief Justice of England and Wales, a position from which he retired in September 2005.
